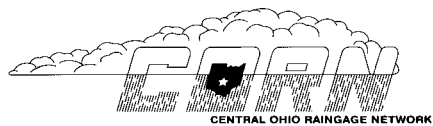

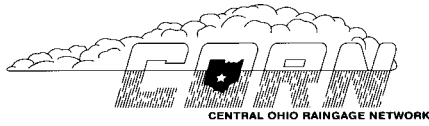

If no distance or direction is included with the Station I.D., the station is located within the community, or less than one mile from the identified landmark.

SUMMARY INFORMATION for October 2003

Precipitation averaged below normal over all 4 sectors of our network during October. Monthly totals at individual stations within our official 10-county area ranged from 1.20 inches at Thurston 2E in northeastern Fairfield County to 3.25 inches at Amanda 2WSW in southwestern Fairfield County. Outside of our 10-county network area, our observer at New Lebanon in Montgomery County reported 3.65 inches of total rainfall for the month. Sector averages for the month were as follows: NW = 2.01 inches; NE = 1.99 inches; SE = 1.85 inches, and SW = 1.77 inches. The 4-sector average for the month was 1.91 inches; normal precipitation for October at Port Columbus is 2.31 inches. The last time that all 4 sectors reported below normal precipitation in the same month was in June 2003. There was no snowfall reported in the Central Ohio area during October. The most significant storm of the month occurred on October 14.

A low pressure center, with its associated warm and cold fronts, moved across the Central Ohio area during the day on October 14. Rainfall associated with the two fronts moved across the area from about 9 a.m. until about 5 p.m., and was then followed by a break in the rainfall for about 1.5 hours. As the low pressure center began to move off to the east of our area, additional rainfall from the back side of the low pressure circulation occurred over our area from about 6:30 p.m. until almost midnight. Most of our observers within the official 10-county network reported at least 0.7 of an inch of rainfall from the combined storms, with as much as 1.4 inches of rain falling in the City of Marion. Outside of our 10-county area, our observer at New Lebanon recorded 2.33 inches of rainfall from the storms.



Precipitation for calendar year 2003 continues to average well above normal over all four sectors of the network, in spite of the drier-than-normal October. Annual totals at individual stations range from 28.91 inches at Lancaster 2NW in central Fairfield County to 55.40 inches at O'Shaughnessy Dam 2E in extreme southwestern Delaware County. Sector averages for the year-to-date are as follows: NW = 41.91 inches; NE = 42.37 inches; SE = 37.34 inches, and SW = 39.54 inches. The 4-sector average for the year is 40.29 inches; normal precipitation for the period of January through October at Port Columbus is 32.38 inches. With two months remaining in the calendar year, the 55.40 inches reported at O'Shaughnessy Dam 2E has already broken the all-time record annual precipitation value of 53.16 inches at Port Columbus, recorded in 1990. CORN gages 3, 13, 27, 43, 50 and 63 will also break the annual record at Port Columbus if they receive just normal precipitation over the last two months of the year. It is not likely that anyone will break the all-time record for annual precipitation for our network, however, this year. The all-time highest annual precipitation value for our network is 69.25 inches, recorded in 1990 at a "retired" gage location that is only about 2.5 miles northeast of the current O'Shaughnessy Dam 2E station. The Palmer Drought Severity Index for Central Ohio was basically unchanged from last month, and reservoir pool levels in general dropped slightly during the month. The large drop in pool elevation at Alum Creek Reservoir was in association with construction activities occurring at the dam.
