September 4: Periods of scattered, slow-moving showers and thundershowers occurred over Central Ohio from late evening on the 3rd through the early morning hours of the 5th. The majority of our observers recorded between 1 and 2 inches of rain, with locally higher amounts of 2 to 2.5 inches reported by volunteers in Sunbury and Commercial Point.

September 26: Scattered showers from about mid-morning to late afternoon on the 26th produced roughly 0.5" to 1.0" of rainfall over most of the Central Ohio area.

Miscellaneous: 75% of those gages that have recorded annual precipitation totals to date have already exceeded Port Columbus' normal annual precipitation for an entire year ... with 3 months yet to go!
