- Volunteers who report daily precipitation totals submit their data directly to Bob Davis or Kristi Gardner (CORN). Data for gages with monthly totals only have been obtained from Scott Kirk at ODNR / Division of Soil and Water Resources or from NWS website.
- The Central Ohio Raingage Network is a group of volunteer precipitation observers who typically report precipitation measurements taken from plastic rain gauges of at least 5-inch capacity.
- "Station I.D." nomenclature is adapted from National Weather Service (NWS) procedure for naming Cooperative Observer stations. The station is identified either by the nearest community or well-known landmark, along with a distance in miles, and direction from that community or landmark, if it exceeds approximately 1 mile. For example, Marion 2N represents a site that is approximately 2 miles north of the City of Marion. If no distance or direction is included with the station I.D., the station is located within the community, or less than 1 mile from the identified landmark.
- Gage ID numbers from 201-213 and 301-304 represent volunteers whose gages are located outside of the 10-county area officially designated by the NWS as the "Central Ohio" climatic section. The "Central Ohio" area consists of Marion, Morrow, Union, Delaware, Licking, Madison, Franklin, Fairfield, Fayette and Pickaway Counties.
- The CORN logo used on data recording sheets was designed by Steve Davies and digitized by Mike Moore.

Central Ohio Significant Storm Information for Month:

Mar. 3-4: Scattered rain showers from about 11 a.m. on the 3rd to about 8 a.m. on the 4th, changing to spotty mist and light rain until about 11 a.m. on the 4th. Light snow then fell later in the day, from about 6 p.m. to 10 p.m. at Port Columbus, with heavier snow falling later south and east of Columbus. While Columbus and Franklin County generally reported an inch or less of snowfall, Laurelville in Pickaway County reported 4" of snowfall; Washington Court House in Fayette County reported 3" of snowfall, and Fairfield County had reports of 1.3" to 2" of snowfall. Liquid equivalent of precipitation ranged from 0.6" to 1.6", with the heaviest amounts reported from the southern half of our network.

March 13-14: Steady, generally light rain fell over Central Ohio from about noon on the 13th until about 11 a.m. on the 14th. Total rainfall amounts ranged from 0.84 to 1.40 inches within the official 10-county Central Ohio area.
